TOURNAMENT RULES

1. This tournament is sanctioned by the BTBA and the BTBA's General Playing and Tournament Rules will govern this event. BTBA Membership will be checked on the BTBA database which is accessible at btba.org.uk
2. Eligibility for this tournament shall be in accordance with the following rules:
 - (a) Be eligible to hold a British Passport, or have lived continuously in the UK for least five years.
 - (b) Have been born within the boundary of Derbyshire, or
 - (c) Have resided within the boundaries of Derbyshire for not less than one year at the time of registration.
3. Age rules: Under 18 - Under 18 years of age at the 1st September 2018 Under 15 - Under 15 years of age at the 1st September 2018
4. Each bowler will bowl six games, changing lanes after every two games in accordance with a pre-arranged schedule. Bowlers arriving late will commence scoring at the frame in progress.

NOTE - Anyone, who is unable to attend the trials, should contact John Hooper direct, prior to the trials taking place. Only exceptional circumstances will be considered, i.e. unavailable because of tournament commitments.
5. Final placing will be based on the total scratch pin fall on completion of the six games. The bowlers placed in the top two positions in their respective groups i.e. Under 18's and Under 15's will be guaranteed at least two games in their respective group during the 2019 Inter-Counties tournament.
6. Where possible the top ten boys and girls in their respective group will be registered as County players for the Derbyshire squads in 2019

NOTE 1 - Qualification for the County squad does not guarantee a place in the team selected to represent Derbyshire in the Inter-Counties tournament, with exception of the top bowlers. (Ref. Rule 5).

NOTE 2 - In accordance with Rule 7 of the Derbyshire County Tenpin Bowling Team Constitution, a minimum number of bowlers must qualify from these trials in order for teams to be entered. If this minimum is not achievable the tournament will be cancelled and the entry fees will be refunded.
7. A provisional ball shall be rolled in the case of any dispute relating to pin fall which cannot be resolved immediately. Protests must be lodged with the Tournament Manager within one hour of completion of the game in question and confirmed in writing within 72 hours.
8. The Tournament Manager will be John Hooper whose decision on all matters will be final, subject to appeal to the B.T.B.A.
9. The tournament entry fee of £20-00 is to be submitted with the completed entry form. This fee includes lineage, Local Area Association expenses and £2.00 Tournament Sanction Fee. Prize fund fee is not applicable. All cheques to be payable to D.A.T.A. Entry fees to be sent, with the entry fee to reach the Tournament Manager no later than midnight on Sunday 25 November 2018. Tournament entries received after this deadline will only be accepted at the Tournament Managers discretion.
10. No competitor will be allowed to smoke or consume alcohol anywhere in the centre during the tournament. Bad language, improper gestures, the abuse of bowling equipment or machinery is forbidden. Breach of this rule will result in the individual being disqualified from the trials.
11. Competitors will wear the correct bowling attire in the playing area shirts must bear the name of the players YBC or the players name. Sponsors names (excluding alcohol or tobacco products) are permissible. Dark trousers for boys must be worn. Shorts or denim clothing of any description will not be permitted, however Skorts (skirt/shorts) will be allowed for female competitors. The wearing of hats during play is not allowed unless at the Tournament Managers discretion. Mobile phones and their use in the player's area is not allowed – they must be switched off during play.
12. *PHOTOGRAPHS* – Before, during, and after the event there could be photography, filming or video taken of participants and medal winners by anyone, attending the event, either as an official, spectator, parent or guardian. If you (as a participant, parent or guardian) object to this, you must make your objections known to the Tournament Manager prior to the event starting and reasonable adjustments will be made.
13. The tournament will take place at CHESTERFIELD Bowling Centre on Saturday 1 December 2018. Registration will be 08.30 a.m. Bowling will commence at 09.00 a.m. A draw for lane allocation will take place on the day of the tournament.
