Playing Rules

The Trials are sanctioned by the BTBA and the general playing and tournament rules plus the following special rules will govern the tournament.

Eligibility

The Trials are open to any individual who is a current member in good standing of the BTBA or Affiliated Association. BTBA Membership will be checked on the BTBA database which is accessible at btba.org.uk

They must be eligible to hold a British Passport , or have lived continuously in the UK for at least 5 years.

They must have been born within the boundaries of their County, or have resided within the boundaries of their County for not less than one year at the time of registration. Serving members of HM Forces (not participating in the RAF team) and their dependants shall qualify after six months residential period.

Format

A six game series will be bowled changing lanes after every game. Two lane dressing patterns will be used.

Disputes

A provisional ball shall be rolled in the case of a dispute, which cannot be resolved quickly. Any protest must be made verbally to the Tournament Manager at the time and confirmed in writing 30 minutes after the Tournament.

The Tournament Manager's decision shall be final subject to appeal to the BTBA

The Tournament Manager reserves the right to reject any entry.

The Tournament Manager will be Allan Pearson who will be assisted by other members of the Area Committee as required.

Dress

Participants must be dressed neatly and wear clothing appropriate for public appearance No participant will be permitted to bowl in shorts, jeans or denim skirts.

The Tournament Committee shall be the judge in this matter.

Entry Fee

The cost of entry will be £24.00 which will cover the cost of lineage, expenses and £2 Tournament Sanction Fee

Registration

Registration will be 30 minutes prior to the relevant squad times at which time bowlers that are non BTBA Members will be fined £22.50.

Closing Date

The closing date for entries will be on Monday 4th February 2019 @ 9.00pm

Special Notes

All bowlers must bowl on the designated date and time.

Eating and drinking of alcoholic beverages is forbidden during play. Non-alcoholic drinks may be consumed outside the players area.

Before, during, and after the event there could be photography, filming or video taken of participants and medal winners by anyone attending the event, either as an official, spectator, parent or guardian. If you (as a participant, parent or guardian) object to this, you must make your objections known to the tournament manager prior to the event starting and reasonable adjustments will be made.

Any bowler qualifying for the county squads must be prepared to attend at least one Practice Session.
