# 2019 Lincolnshire Senior County Team Trials

The Lincolnshire Senior County Team Trials shall be BTBA sanctioned. The General Tournament and Rules of the BTBA shall apply, together with the BTBA Inter-County Rules and Regulations (most recent revision) and the following special rules:

## 1. Eligibility: Bowlers must

- be aged 50 on or before the 1<sup>st</sup> June prior to the Tournament.
- be a current BTBA member in good standing. Memberships will be checked on the database which can be viewed on btba.org.uk.
- Bowlers may join on the day or pay a fine of the current cost of BTBA membership.
- Be eligible to hold a British passport or lived continuously in the UK for at least 5 years.
- have been born within the County boundaries of Lincolnshire (as established in 1961) or have resided within these boundaries for not less than 12 months at the time of registration (6 months for HM Forces and their dependents).

## 2. Placings:

- Final placings will be decided on total scratch pinfall only
- The top 2 ladies and men will be guaranteed the opportunity to represent Lincolnshire in at least 2 games of the Senior Inter-County Tournament.
- The remainder of each squad of up to 15 bowlers will be selected from the results of these trials only, together with league and tournament averages and get togethers.

## 3. Format and costs:

- Each bowler shall bowl 6 games in Trios format (provided that numbers permit), changing lanes after every 3 games (TBD).
- Entry fees will be £20 per bowler. (This includes Tournament Sanction Fee £2).

- Their decision on all matters will be final, subject to appeal to the BTBA.
- **Bowlers unable to bowl on February 24<sup>th</sup> should seek advice from their Team Manager.**
- Protests must be lodged with the TM Team within one hour of the game in question and confirmed in writing within 72 hours.
- A provisional ball shall be bowled if a dispute relating to a foul or pinfall cannot be resolved immediately.

## 5. Entries:

- Entries can be lodged provisionally with any of the Tournament Management Team. Early notification of intent to enter would be much appreciated.

## 6. Times and Dates:

- Bowling will start at 10.00 am on Sunday, 24<sup>th</sup> February 2019
- Bowlers should register at least 30 minutes prior to bowling
- The qualifying round of the Senior Inter-County Tournament is set for 1st and 2nd June, Venue TBD and the Final provisionally set for 12<sup>th</sup> and 13<sup>th</sup> of October 2019.
