# 1. Purpose

To promote competition between eligible Counties of Great Britain to produce County Champions for Male and Female Teams at all levels.

# 2. Management

The Tournament will be governed by the Inter County Secretaries appointed by the National Council of the BTBA.

# 3. Eligibility

a) Registration of Counties will only be accepted from:

- i) County or Area Associations of the BTBA and Affiliated Associations.
- ii) Counties forming part of any Area Association of the BTBA.
- iii) In the Adult tournament only an RAF team formed from serving Royal Air Force personnel.

Note - For the sake of clarity within these rules, from here on the word County in association with the Adult tournament is assumed to include the RAF in all eligible tournaments

b) The following qualifications are required for County representation:

- i) The individual must be a current member in good standing with the BTBA or Affiliated Association.
- ii) The individual must be eligible to hold a British Passport or have lived continuously in the UK for at least 5 years.
- iii) The individual must have been born within the boundaries of their County, or
- iv) The individual must have resided within the boundaries of their County for not less than one year at the time of registration. Serving members of HM Forces (not participating in the RAF team) and their dependants shall qualify after six months residential period.

RAF Team only: RAF personnel must be serving personnel, stationed in the UK at the time of the RAF selection tournament and not currently registered for another County.

c) All geographical County Boundaries will be those as established in 1961.

d) All applications for change of registration must be lodged for a period of one year before becoming effective. The one-year waiting period shall commence for unregistered players from the date of receipt of written notification, for registered players from the end of the final in the year of application;

- i) Until their new qualification takes effect, these individuals will continue to be eligible to play for their previous County.

- ii) No individual may play for different Counties in successive years without first having given one year's notice of intent to the relevant Inter County Secretary who in turn will notify the BTBA Head Office.
  - iii) Individuals who fail to notify the Inter County Secretary of their intent to change Counties may if they desire, but not necessarily: After one complete year (during which time their name must not be registered for any County) they are then at liberty to register for a new County, provided they meet the criteria of Rule 3b.
  - iv) RAF 'County' registered players leaving the Service must advise the Adult Inter-County Secretary in accordance with eligibility rule d above of the county to which they wish to become affiliated to either by birth or residence in accordance with the eligibility rules above.
- e) Orphan Bowlers
- i) If a bowler lives and was born in a County that has no local association, then if they bowl in a league in another area they can declare to the ICC secretary that they wish to participate for that County. If either their County of residence or birth form an accepted County association this temporary attachment will be rescinded. ii) Bowlers who live or were born in a County with an association who cannot raise a team to play then this is unfortunate, but the bowler will be unable to play.
- f) Notice of Intent. Counties wishing to participate must send notification to the relevant Inter County Secretary as follows:

Seniors	14 <sup>th</sup> February
Adults	31 <sup>st</sup> January
Under 12's	31 <sup>st</sup> January
Under 16's	31 <sup>st</sup> January
Under 12's	30 <sup>th</sup> January

This is to be followed by the registration fee (determined by the BTBA) to arrive with the appropriate ICC Secretary no later than the following dates:

For Adult and Senior Championships:

A reduction in the registration fee coupled with a fee for those counties playing in the finals is being considered. This will be dependent on where the finals will be. A survey to be sent to the counties in January regarding the venue for the finals.

Seniors	31 <sup>st</sup> March
Adults	30 <sup>th</sup> April
Under 22's	30 <sup>th</sup> April
Under 16's	28 <sup>th</sup> February
Under 12's	28 <sup>th</sup> February

Fees will not be refundable. The fee will be used to defray the expenses of the Final.

- g) Age Eligibility

#### Senior

- Senior participants must be aged 50 on or before the 31<sup>st</sup> December in the year of the Championship.

#### Adult

- No specific age criteria.

#### Junior Championships

- Under 22 at any point during the year of the tournament.
- Under 16 at any point during the year of the tournament -
- Under 12 at any point during the year of the tournament

## 4. General

Junior bowlers may only play in the Under 22's and Adult tournaments if in possession of a standard BTBA membership.

## 5. Selection – All Levels

- a) A BTBA or Affiliated Association Sanctioned Tournament for selection purposes must be held in a certified centre and there must be equal opportunity for all members to represent their County. It is not necessary that the certified centre chosen for the tournament be within the jurisdiction of the County.
- b) All County Trials are organised by the BTBA not the NAYBC hence the Tournament Sanction Fee (TSF) will also apply to U12/U16/U22 divisions.
- c) Entry Forms for the tournament must include a declaration of eligibility to be completed by the participants.
- d) The entry form for the U12/U16/U22 tournaments must include the following:

Before, during, and after the event there could be photography, filming or video taken of participants and medal winners by anyone attending the event, either as an official, spectator, parent or guardian.

If you (as a participant, parent or guardian) object to this, you must make your objections known to the tournament manager prior to the event starting and reasonable adjustments will be made.

- e) To be eligible for selection, Individuals must participate in the selection tournament. At the discretion of the County and Team England Managers, England squad members may be exempt and seeded into their eligible age group and no other.
- f) All-county selection tournaments will be played scratch.

- g) The top two bowlers from each of the county selection tournaments (County Trials) must be given the opportunity to play at least two games during the qualifying round.

**Note.** This does not necessarily mean in any of the tournaments that these two players need bowl at the same time.

- h) The results of the selection tournaments must be returned with the list of registered players and their BTBA card expiry date to the relevant Inter County Secretary by the following dates:

Seniors	30 <sup>th</sup> April each year
Adults	14 <sup>th</sup> June each year
Juniors	U12, U16 and U22 – Dates to be advised by ICC sec

- g) The top two players from the selection tournament must be listed first on the registration form that is sent to the relevant ICC Secretary.
- h) A maximum of 15 players may be registered in each division
- i) In the event of the maximum number of bowlers not being registered by the dates stated then additions may only be made by the authority of the relevant ICC Secretary.

## 6. Formats & General Rules

- a) All matches and games shall conform to BTBA Rules and Regulations.
- b) There will be 2 divisions in each Championship; Male and Female.
- c) Each eligible County shall be permitted to enter one team in each division.
- d) It is the responsibility of each County to arrange for provision of suitable shirts of the same colour and design bearing the name of, and if possible, the crest of, their County. Reference to a commercial sponsor may appear but, shall not be more than half the size of the County Name or be the predominant feature. Individual's names are acceptable on the front or back.
- e) No denim or shorts of any description will be allowed. Ladies/girls may wear skorts, skirts, trousers, ¾ length trousers or sports leggings. Men/boys can wear trousers only. Whichever attire is worn it must be of the same colour.

**NB – Sports leggings are deemed as not see through. The acceptable length of skirts and skorts is a length that is no shorter than the tip of the longest finger when the bowler's arms are resting by their side.**

# Seniors

## 1. Format

- a) The Country will be split into four qualifying groups nominally North, Midlands, South East and South West for both male and female divisions with an equal number of counties, as far as is practical, in each group. The groups will be compiled by the Inter-County Secretary and confirmed by the General ICC Secretary.
- b) Each team will play six games in the qualifying round during the first weekend in June. The top three men's teams and two ladies from each group will qualify for the final
- c) If possible, the round will be played on the Sunday only, subject to the number of entries and the availability of a suitable hosting centre. If necessary, a draw will be made (normally at the BTBA Nationals) to determine which day the county will play on in the qualifying round. The draw will initially be based on the counties with both a male and female team and then by those with just one. This assures an even balance of teams across both days.
- d) The final will be an eleven-game round robin for the Men and seven for the ladies played over the third weekend in October.

## 2. Qualifying Rounds - 1<sup>st</sup> Sunday in June

- a) Venues for the qualifying rounds will be notified as soon as possible after the closing date for entries. The County that hosts a qualifying round will be responsible for applying for the tournament sanction for that qualifying round.
- b) Times of registration will be announced by the Inter County Secretary or host County to all participating Counties in the qualifying round.
- c) Each player must be a **current** BTBA or Affiliated Association Member. Any bowlers whose membership is out of date will not be allowed to play. If a bowler is subsequently found NOT to be a member then their scores will be removed. Teams or players not registered by the stated time will not be allowed to bowl, except in an emergency or unless otherwise agreed by the ICC Secretary at the time of registration.
- d) In the event of a tie for a position in the final, the team with the lower difference between its highest and lowest team game will go through.
- e) Lane dressing will be undertaken after three games.
- f) The Captain / Manager of any County may introduce a registered substitute at the end of any game. There will be no substitution during a game, except in an emergency.
- g) The Tournament Manager must send the results of the qualifying round either by first class post or by email to the Inter County Secretary on the next working day after completion of the qualifying event.

- h) **No** Food or Drink will be consumed in the playing area at any time during the Tournament. Non-alcoholic beverages may be taken outside of the playing area.
- i) Anyone whose conduct is considered to be derogatory to the best interests of the Tournament maybe disqualified immediately.
- j) Any individual considered to be under the influence of alcohol will be disqualified immediately.

#### 4. Grand Final - 2<sup>nd</sup> weekend in October (subject to school half term dates)

- a) The rules covering the qualifying round plus the following special rules govern the final.
- b) Application for sanction will be made by the Inter County Secretary.
- c) Each competing County shall be permitted to nominate:
  - i) Male: Seven players from their registered squad with five bowlers for each game being from those nominated.
  - ii) Female: Six players from their registered squad with four bowlers for each game being from those nominated.
- d) Time of registration will be announced by the Inter County Secretary and nominally will be 45 minutes before the opening ceremony. All participants in the Final must be a current BTBA or Affiliated Association Member. Any bowlers whose membership is out of date will not be allowed to play. If a bowler is subsequently found NOT to be a member then their scores will be removed. Teams or players not registered by the stated time will not be allowed to bowl, except in an emergency or unless otherwise agreed by the ICC Secretary at the time of registration.
- e) Each team will compete on a round robin basis, playing one game against each other to a prearranged schedule. Teams will be awarded 20 bonus pins per bowler for a win (100 for men's team and 80 for women's) and 10 pins per bowler for a draw.
- f) The final will be two-day event. The men's division will play with six games on the Saturday and five games on the Sunday. The ladies will play two games on the Saturday and five on the Sunday. The awards will be presented on completion of the schedule.

#### 5. Awards

All registered bowlers at the Final will be eligible for an award whether they have participated in the Final or not.

#### 6. Ties & Team Withdrawals

- a) In the event of a tie for first place the County with the highest pinfall will be declared the Champions. If this still results in a tie, then the highest last game will preside and so on.

- b) If during the round robin a team or individual withdraws, any remaining matches against that team will continue with win bonuses awarded accordingly. Any past results from previous rounds will stand.

## 7. Protests

Protests must be made verbally at the time of dispute and confirmed in writing to the Inter County Secretary within 30 minutes of the game in which the infringement took place.

## 8. Buffet / Dance

Each nominated bowler for the Final will have a free of cost ticket made available. Should further tickets be required, they shall be made available (where possible) at a cost determined by the ICC Secretary. TEAM TICKETS ARE NOT TRANSFERABLE.

## 9. Communications

All correspondence will be addressed to the Local Area Association Secretary or a nominated representative.

# Adults

## 1. Format

- a) The Country will be split into three qualifying groups nominally North, Central and South for both male and female divisions. There will be an equal number of counties, as far as is practical, in each group. The groups will be compiled by the Inter-County Secretary and confirmed by the BTBA. Due to the non-specific location of the RAF team they will be allocated to the most appropriate group.
- b) Each team will play six games in the qualifying round over the first weekend in September.
- c) The final will be an eleven game round robin played over the first weekend in November.

## 2. Qualifying Rounds - First Weekend in September

- a) Venues for the qualifying rounds will be notified as soon as possible after the closing date for entries. The County that hosts a qualifying round will be responsible for applying for the tournament sanction for that qualifying round.
- b) Times of registration will be announced by the Inter County Secretary to all participating Counties in the qualifying round.
- c) In each group (North, Central & South) and in each division (male and female) each county will play six games on a scratch basis. The four highest scoring teams over the six games on each day from each group will qualify for the Final. In the event of a tie for a position in the final, the team with the lower difference between its highest and lowest team game will go through.
- d) Lane dressing will be undertaken after three games.
- e) The Captain / Manager of any County may introduce a registered substitute at the end of any game. There will be no substitution during a game, except in an emergency.
- f) The Tournament Manager must send the results of the qualifying round either by first class post or by email to the Inter County Secretary on the next working day after completion of the qualifying event.
- g) No Food or Drink will be consumed in the playing area at any time during the Tournament. Non-alcoholic beverages may be taken outside of the playing area.
- h) Anyone whose conduct is considered to be derogatory to the best interests of the Tournament maybe disqualified immediately.
- i) Any individual considered to be under the influence of alcohol will be disqualified immediately.

### 3. Grand Final – First weekend in November

- a) The rules covering the qualifying round plus the following special rules govern the final.
- b) Application for sanction will be made by the Inter County Secretary.
- c) Each competing County shall be permitted to nominate:
  - i) Male: Seven players from their registered squad with five bowlers for each game being from those nominated.
  - ii) Female: Seven players from their registered squad with five bowlers for each game being from those nominated.
- d) Time of registration will be announced by the Inter County Secretary and nominally will be 45 minutes before the opening ceremony. All participants in the Final must be a current BTBA or Affiliated Association Member. Any bowlers whose membership is out of date will not be allowed to play. If a bowler is subsequently found NOT to be a member then their scores will be removed. Teams or players not registered by the stated time will not be allowed to bowl, except in an emergency or unless otherwise agreed by the ICC Secretary at the time of registration.
- e) Each team will compete on a round robin basis, playing one game against each other to a prearranged schedule. Teams will be awarded 20 bonus pins per bowler for a win (100 per team) and 10 per bowler for a draw.
- f) The final shall be a two-day event with five games being played on the Saturday and six games on the Sunday. The awards will be presented on completion of the schedule.

### 4. Awards

All registered bowlers at the Final will be eligible for an award whether they have participated in the Final or not.

### 5. Ties & Team Withdrawals

- a) In the event of a tie for any place the County with the highest pinfall will be declared the Champions. If this still results in a tie, then the highest last game will preside and so on.
- b) If during the round robin a team or individual withdraws, any remaining matches against that team will continue with win bonuses awarded accordingly. Any past results from previous rounds will stand.

### 6. Protests

Protests must be made verbally at the time of dispute, and confirmed in writing to the Inter County Secretary within 30 minutes of the game in which the infringement took place.

## 7. Buffet / Dance

Each nominated bowler for the Final will have a free of charge ticket made available. Should further tickets be required, they shall be made available (where possible) at a cost determined by the ICC Secretary. TEAM TICKETS ARE NOT TRANSFERABLE.

## 8. Communications

All correspondence will be addressed to the Local Area Association Secretary or a nominated representative.

# Under 22's

## 1. General

- a) Counties must give notice of intention to compete in the tournament, in writing, to the Inter County Secretary by the 31st January. Each county will be eligible to enter one team in each division. The registered squad of up to 15 players is to be provided by no later than midnight on the 28<sup>th</sup> February with their dates of birth and BTBA membership number.
- b) A provisional ball will be rolled if a dispute relating to pinfall cannot be resolved immediately.
- c) Protests must be lodged with the ICC Secretary / Tournament Manager within 30 minutes of the infraction occurring and confirmed in writing before the presentation.
- d) NO COMPETITOR will be allowed to:
  - i) Consume alcoholic beverages during play, lane changes, or the duration of the day's play.
  - ii) Wear headgear, but subject to the discretion of the Inter County Secretary.
  - iii) Consume Food or Drink in the playing area at any time during the Tournament. Non-alcoholic beverages may be taken outside of the playing area.
- e) Only one licensed instructor is allowed in the playing area at any time. BTBA rule 330 applies for details on coaching/instruction. Licenses must be displayed at all times.
- f) Mobile phones are to be switched off in the player's area.

## 2. Format

- a) The format for play will be in 2 divisions:
  - i) Male Four Person Team.
  - ii) Female Four Person Team
- b) Each team will play five games in the qualifying round on the Saturday and three further games on the Sunday.
- c) Each county will be eligible to enter one team in each division and may lodge with the ICC Secretary an entry of up to 15 players for each division.
- d) At the event up to 7 male team members can be registered and 7 female team members.
- e) Anyone whose conduct is considered to be derogatory to the best interests of the Tournament maybe disqualified immediately.
- f) Any individual considered to be under the influence of alcohol will be disqualified immediately.

### 3. Qualifying

- a) Each player must be a **current** BTBA or Affiliated Association Member. Any bowlers whose membership is out of date will not be allowed to play. If a bowler is subsequently found NOT to be a member then their scores will be removed. Teams or players not registered by the stated time will not be allowed to bowl, except in an emergency or unless otherwise agreed by the ICC Secretary at the time of registration.
- b) QUALIFYING ROUNDS - Each team will bowl two sets. A series of 5 games will be bowled on the Saturday with a further three on the Sunday morning, changing lanes after each game.
- c) QUALIFIERS FOR THE FINALS - This will be the 8 teams with the highest pinfall in each division seeded 1 - 8. In the event of a tie for any place then the team with the highest individual team game will go through. If still tied after this then the next game will count etc until a decision is reached.
- d) The Captain/Manager of any County may introduce a registered substitute at the end of any game. There will be no substitution during a game, except in an emergency.

### 4. Final

The finals will be a single game matchplay knockout. The team seeded 1st will play the team seeded 8th, 2nd place v 7th place etc. The winner will go through to the next round. The teams seeded 1st and 2nd if successful, in the rounds can only meet in the final match. The winner of the second round matches will go through to the final and the losers will play against one another for the bronze medal position.

### 5. Awards

Place awards will be given to all team members (7 boys & 7 girls).

### 6. Ties

In the event of a tie for any place in the qualification stage the County the highest last game will preside and so on. During the Matchplay final a 9/10 frame roll off will decide.

### 7. Protests

Protests must be made verbally at the time of dispute and confirmed in writing to the Inter County Secretary within 30 minutes of the game in which the infringement took place.

### 8. Communications

All correspondence will be addressed to the Local Area Association Secretary or a nominated representative.



# Under 16's

## 1. General

- a) The County selection tournament results must contain a full list of participants including their date of birth, BTBA membership number and the YBC they represent. They must be listed in the result order. These must be sent by each County to the Junior ICC Secretary for verification before entry into the Championships.
- b) A provisional ball will be rolled if a dispute relating to pinfall cannot be resolved immediately.
- c) Protests must be lodged with the Tournament Manager/Junior ICC Secretary within 30 minutes of the infraction occurring and confirmed in writing before the end of the tournament.
- d) Only one licensed instructor is allowed in the playing area at any time. BTBA rule 330 applies for details on coaching/instruction. Licenses must be displayed at all times.
- e) NO COMPETITOR will be allowed to:
  - i) Consume alcoholic beverages during play, lane changes, or the duration of the day's play.
  - ii) Wear headgear, but subject to the discretion of the Inter County Secretary.
  - iii) Consume Food or Drink in the playing area at any time during the Tournament. Non-alcoholic beverages may be taken outside of the playing area.
- f) Mobile phones are to be switched off in the player's area.

## 2. Format

- a) The tournament will be played in 2 divisions:
  - i) Male Four Person Team
  - ii) Female Four Person Team
- b) Each county will be eligible to enter one team in each division and may lodge with the ICC Secretary an entry of up to 15 players for each division.
- c) At the event up to 7 male and 7 female team members can be registered
- d) The Captain/Manager of any County may introduce a registered substitute at the end of any game. There will be no substitution during a game except in an emergency.
- e) QUALIFYING ROUNDS - Each team will bowl a series of 5 games changing lanes after each game.
- f) QUALIFIERS FOR THE FINALS - This will be the 8 teams (4 if fewer than 8 teams enter) with the highest pinfall in each division seeded 1 - 8. In the event of a tie for any place then the team with the highest individual team game will go through. If still tied after this then the next game will count etc until a decision is reached.

### 3. Finals

The finals will be a single game matchplay knockout. The team seeded 1st will play the team seeded 8th, 2nd place v 7th place etc. The winner will go through to the next round. The teams seeded 1st and 2nd if successful, in the rounds can only meet in the final match. The winner of the second-round matches will go through to the final and the losers will play against one another for the bronze medal position.

### 4. Awards

Place awards will be given to all team members (7 boys & 7 girls). The individuals with the highest average and highest score over the qualifying games will be made in both divisions subject to a minimum of 4 games.

### 5. Ties

In the event of a tie for any place in the qualification stage the County the highest last game will preside and so on. During the Matchplay final a 9/10 frame roll off will decide.

### 6. Protests

Protests must be made verbally at the time of dispute and confirmed in writing to the Inter County Secretary within 30 minutes of the game in which the infringement took place.

### 7. Correspondence

All correspondence will be addressed to the Local Area Association Secretary or nominated representative.

## Under 12's

### 1. General

- a) The County selection tournament results must contain a full list of participants including their date of birth, BTBA membership number and the YBC they represent. They must be listed in the result order. These must be sent by each County to the Junior ICC Secretary for verification before entry into the Championships.
- b) A provisional ball will be rolled if a dispute relating to pinfall cannot be resolved immediately.
- c) Protests must be lodged with the Junior Inter County Secretary within 30 minutes of the infraction occurring and confirmed in writing before the presentation.
- d) Only one licensed instructor is allowed in the playing area at any time. BTBA rule 330 applies for details on coaching/instruction. Licenses must be displayed at all times.
- e) NO COMPETITOR will be allowed to:
  - i) Consume alcoholic beverages during play, lane changes, or the duration of the day's play.
  - ii) Wear headgear, but subject to the discretion of the Inter County Secretary.
  - iii) Consume Food or Drink in the playing area at any time during the Tournament. Non-alcoholic beverages may be taken outside of the playing area.
- f) Mobile phones are to be switched off in the player's area.

### 2. Format

- a) The tournament will be played in 2 divisions:
  - i) Male Three Person Team
  - ii) Female Three Person Team
- b) Each county will be eligible to enter one team in each division and may lodge with the ICC Secretary an entry of up to 15 players for each division.
- c) At the event up to 6 male and 6 female team members can be registered
- d) The Captain/Manager of any County may introduce a registered substitute at the end of any game. There will be no substitution during a game except in an emergency.
- e) QUALIFYING ROUNDS - Each team will bowl a series of 5 games changing lanes after each game.
- f) QUALIFIERS FOR THE FINALS - This will be the 8 teams (4 if fewer than 8 teams enter) with the highest pinfall in each division seeded 1 - 8. In the event of a tie for any place then the team with the highest individual team game will go through. If still tied after this then the next game will count etc until a decision is reached.

### 3. Finals

The finals will be a single game matchplay knockout. The team seeded 1st will play the team seeded 8th, 2nd place v 7th place etc. The winner will go through to the next round. The teams seeded 1st and 2nd if successful, in the rounds can only meet in the final match. The winner of the second round matches will go through to the final and the losers will play against one another for the bronze medal position.

### 4. Awards

Place awards will be given to all team members (6 boys & 6 girls). The individuals with the highest average and highest score over the qualifying games will be made in both divisions subject to a minimum of 4 games.

### 5. Ties

In the event of a tie for any place in the qualification stage the County the highest last game will preside and so on. During the Matchplay final a 9/10 frame roll off will decide.

### 6. Protests

Protests must be made verbally at the time of dispute and confirmed in writing to the Inter County Secretary within 30 minutes of the game in which the infringement took place.

### 7. Communications

All correspondence will be addressed to the Local Area Association Secretary or nominated representative.
