

Trials Rules

1. The trials will be B.T.B.A. Sanctioned, and tournament rules will apply to all participants, who must be current members of the B.T.B.A. Failure to produce a valid membership card will result in a fine equivalent to the full BTBA membership fee of £22.50 being levied. (Non-members may join upon payment of the annual fee of £22.50).
2. The trials are open to all members who were born in, or have lived within the Lancashire boundaries (as of 1961 O/S Map) for more than 1 year (serving members of H.M.Forces, and their dependants 6 months).
3. All competitors (Adults, Juniors, Seniors) will bowl 6 (Six) games moving 1 pair of lanes after each game
4. All competitors must be eligible to hold a British Passport.
5. Only competitors who have bowled in these trials, and those who qualified for Team England will be considered for the County squads.
6. No denims or shorts are to be worn.
7. Profane language, or abuse of equipment will not be tolerated, and may result in disqualification.

A provisional ball must be rolled if a dispute relating to pin fall cannot be resolved immediately. Protests must be confirmed in writing to the tournament manager within 72 hours of the game in which the infraction occurred.

8. The tournament manager's decision on any matter is final, subject to an appeal in writing to the B.T.B.A.
9. The closing date for entries will be midnight 2nd February 2019
10. Registration will be at 09.15am for a 09:45am roll off.
11. No smoking is permitted in the bowling centre at any time.
12. Juniors who wish to be considered for Adult squads **MUST** hold a current Standard BTBA card

Before, during, and after the event there could be photography, filming or video taken of participants and cup winners by anyone attending the event, either as an official, spectator, parent or guardian. If you (as participant, parent or guardian) object to this, you must make your objections known to the tournament manager prior to the event starting and reasonable adjustments will be made.

The Managers Cup

The cups will be awarded to both, the lady and the gentleman with the highest OVER 18 SCRATCH AVERAGE, bowled over any of the trial dates, and will be held in the bowlers until the next Lancashire Trials.
