**TOURNAMENT RULES**

1. This tournament is sanctioned by the BTBA and the BTBA's General Playing and Tournament Rules will govern this event. BTBA Membership will be checked on the BTBA database which is accessible at [btba.org.uk](http://btba.org.uk)
  
2. Eligibility for this tournament shall be in accordance with the following rules:
  - (a) Be eligible to hold a British Passport, or have lived continuously in the UK for least five years.
  - (b) Have been born within the boundary of Derbyshire, or
  - (c) Have resided within the boundaries of Derbyshire for not less than one year at the time of registration.
  
3. Each bowler will bowl five games, in team format, changing lanes after every game in accordance with a pre-arranged schedule. Bowlers arriving late will commence scoring at the frame in progress.
  
4. Final placing will be based on the total scratch pin fall on completion of the five games. The bowlers placed in the top two positions will be guaranteed at least two games during the qualifying round of the 2018 Inter-Counties tournament.
  
5. The top fifteen bowlers will be registered for the County squad  
  
NOTE 1 - Qualification for the County squad does not guarantee a place in the team selected to represent Derbyshire in the Inter-Counties tournament, with exception of the top two. (Ref. Rule 4).  
  
NOTE 2 - In accordance with Rule 8 of the Derbyshire County Tenpin Bowling Team Constitution, a minimum number of bowlers must qualify from these trials in order for a team to be entered. If this minimum is not achievable the tournament will be cancelled and the entry fees will be refunded.
  
6. A provisional ball shall be rolled in the case of any dispute relating to pin fall which cannot be resolved immediately. Protests must be lodged with the Tournament Managers within one hour of completion of the game in question and confirmed in writing within 72 hours.
  
7. The Tournament Managers will be John Hooper and Michael Kimberley whose decision on all matters will be final, subject to appeal to the B.T.B.A.
  
8. Entry fee per bowler.  
The tournament entry fee of £30-00 is to be submitted with the completed entry form.  
This fee includes lineage, Local Area Association expenses, and a £2.00 Tournament sanction fee.  
Prize fund fee is not applicable.  
All cheques to be payable to D.A.T.A.
  
9. The tournament will take place at Chesterfield Bowl on Sunday 09 June 2019  
Registration will be 8.30 a.m.                      Bowling will commence at 09.00 a.m.  
A draw for lane allocation will take place on the day of the tournament.
