RULES

1. The Tournament will be sanctioned by the BTBA and as such will be governed by the general playing rules and tournament rules, together with the Inter county championship rules and regulations (January 2019 v1.2)
2. The tournament is open to BTBA members who are in good standing. Non-members will be permitted to play upon payment of a fee equivalent to the annual BTBA membership subscription, currently £25.00. Anyone wishing to join the BTBA on the day will be able to do so online at btba.org.uk and pay by direct debit or credit card. Junior bowlers may only play in the under 22's and adults tournaments if in possession of a standard BTBA membership.
3. Bowlers must make themselves available for the dates in the respective divisions posted at Registration.
4. A provisional ball will be rolled if a dispute relating to pinfall cannot be resolved immediately.
5. Protests must be lodged with the tournament managers, or appointee, within 30 minutes of the infraction-taking place and confirmed in writing before squad selection is made.
6. The Tournament Manager will be Allen Hourihan and Dave Hawkes. Decisions in all matters are final subject to appeal to the BTBA.
7. No competitor is allowed to smoke or consume alcohol during play.
8. Bowlers must wear correct bowling attire no denim of any description will be allowed.
9. Registration on Sunday 20TH February will be at **08:30** Roll off will commence at **09:00**
Registration on Sunday 27TH February will be at **08:30** Roll off will commence at **09:00**
10. Late comers will start at the frame in progress when they are ready to bowl.
- 11. Closing date** for entries will be **Wednesday 16th February 2022 for both adults and senior**

NOTE

The trials will determine squads of the top 7 bowlers for all groups.

ELIGIBILITY

- 1 Each bowler must be a current member of the BTBA in good standing.

Senior aged 50 on or before 31st December in the year of the Championship
Adults no specific age criteria
Under 22 at any point during the year of the tournament
- 2 Each bowler must be eligible a British passport or have lived continuously in the UK for at least 5 years
- 3 Each Bowler must:
 - Have been born within the County of Staffordshire. or
 - Have resided within the County of Staffordshire for at least 1 year at the date of registration. (HM forces 6 months).
- 4 At the discretion of the County and Team England managers England squad members maybe exempt and seeded into their eligible age group and no other.
- 5 The County of Staffordshire is determined by those boundaries in force in 1961.
